**The Asset Management One Co., Ltd. (“the Company”) and its subsidiaries do not solicit retail investors to open accounts or make any investments under any circumstances.**

We are aware that there has been a sharp increase in fraudulent advertisements and impersonation on social media and websites, falsely claiming to represent the Company, its subsidiaries, and their employees. Such frauds are ever increasingly sophisticated.

Please remind again that the Company and its subsidiaries will not contact any retail investors directly for any investment opportunity and/or related activities.

Any websites or accounts other than those listed on the “Notices” page and the “Official Social Media Accounts” page of the Company are fraudulent.

- Advertisements that unauthorizedly use the name or logo of Asset Management One
- Investment solicitations using the photos or names of officers or employees of Asset Management One
- Use of expressions that suggest or guarantee future profits (e.g., "Strong Buy Signal," "A Surge in Stock Prices Is Within Reach")
- Instructions to transfer funds via mobile applications
