## Asset Management One Announces Organizational Changes

Asset Management One Co., Ltd. (Chiyoda-ku, Tokyo; President and CEO: Noriyuki Sugihara) will implement the following organizational changes effective April 1, 2026.

### 1. Reorganization of the Investment Division to Strengthen Investment Capabilities and Enhance the Appeal of In-House Products

- To further strengthen multi-asset investment that emphasizes qualitative judgment, we will integrate the economist and strategist functions of the "Research & Engagement Department" with the asset allocation function of the "Multi-Asset & Quantitative Investments Department". The division will be reorganized into the "Multi-Asset Investments Department."
- To strengthen the function of developing investment solutions that flexibly respond to a broad range of client needs, the quantitative investment functions of the "Multi-Asset & Quantitative Investments Department" will be integrated with the index investment functions of the "Index Solutions Department" and the division will be reorganized into the "Quantitative & Index Strategies Department."
- To strengthen strategic planning, proposal capabilities, and the appeal of investment products, the product management functions of the "Portfolio Solutions Department" will be transferred to the Investment Division, and a new "Product Management Department" will be established.

### 2. Reorganization of the Retail & Wealth Solutions Division to Improve Customer Service Quality

- To strengthen the ability to provide asset management and wealth accumulation solutions tailored to customer needs, the Retail & Wealth Solutions Division will be reorganized from a five-department structure to a six-department structure, including the newly established "Wealth Business Department."
